



Privacy Policy Clappervue BV.

CLAPPERVUE.COM – USER PRIVACY POLICY 08/2016

Data that you have provided to Clappervue.com part of Clappervue BV with registered office in Eindhoven at Torenallee 20 ("Clappervue.com"), may be processed by Clappervue.com for general business purposes, such as the performance of services and complementary services, identification and examination. The data may also be processed for the maintenance of the good relationship with you as the customer, inter alia by forwarding information about Clappervue.com's products and services. When processing data provided by you, Clappervue.com may engage the services of group companies and collaborating partners (data processors as defined in the Local Data Protection Act).

When you register, Clappervue.com asks you to provide data, such as your name, company name, contact details and billing address. You are obliged to ensure that the correct data is provided to Clappervue.com. If data is provided by you which is categorised as personal data, Clappervue.com processes this personal data exclusively in conformity with the Dutch Data Protection Act.

Clappervue.com exclusively saves and uses data that is stated directly to Clappervue.com or in which it is clear when stating the data that this is being provided to Clappervue.com. We only use this data in the context of the implementation of the user agreement concluded with you and furthermore for other service purposes. If personal data is processed other than in the context of the implementation of the agreement concluded with you, this will only be processed with your consent. This consent may be withdrawn again at any time.

Clappervue.com will not share the data provided by you with other organisations, unless:

- Clappervue.com has been given your direct and personal consent to the sharing of this data;
- Clappervue.com must share the data with third parties as part of the agreement concluded with you. These third parties are not authorised to use the data for any other purpose than what is necessary to assist Clappervue.com;
- Compliance with a valid legal request, including the summoning or being summoned; compliance with requests by the court or the commencement of legal proceedings; or
- If Clappervue.com is of the opinion that you are acting in dispute with the conditions of use on our website(s).

Clappervue.com may use the data provided by you for conveying communication for commercial, philanthropic or charitable purposes in relation to your own similar products and services, unless you specified upon registration that you did not set any price here. You can cancel your registration for such communication and e-mail easily free of charge at any time inter alia by means of the deregistration link included for this purpose in the Clappervue.com newsletters.

Every time you visit our site, your (temporary) IP address is recognised automatically and wherever possible the site or e-mail from which you linked to our Website. Clappervue.com does not save and use this data as individual (personal) data, but only to analyse the navigation and pages of the site visited in order in this way to be able to improve the familiarity, functionality and content of our site (and e-mails).

To optimise the service so-called cookies are placed on your computer to a limited extent from our site. Clappervue.com can thus ensure that when you are visiting our site, you do not repeatedly receive or have to input the same information. This data remains on your own computer, but is timed and expires after a period of time. The cookies are used for your ease of use and to improve the website and Clappervue.com. Statistical data can be passed on to Clappervue.com's webmasters and system administrator.

If you wish to react to our privacy policy or if you find that our site or our actions are not in conformity with this privacy-policy, we ask you to contact us via info@Clappervue.com. We introduced the necessary security measures to prevent the loss, unauthorized use or change of information that we receive on our site.

If your information will be used for purposes for which there are (still) no provisions in this privacy policy, we will notify you of this in advance so that you can withhold your consent to this. We allow our customers access to all information from them that we hold upon request. We likewise offer visitors the possibility to correct any incorrect data. You can contact us for this purpose. Clappervue.com's General Terms and Conditions, including this privacy policy, are applicable to each site visit, transaction or contract through our site.

Clappervue.com is authorised to amend these Privacy Policy's from time to time. If the manner in which we process your personal data is changed substantially, we will notify you by means of a prominent notice on our website.
